By indicating your acceptance, you understand, agree, warrant and covenant as follows:
 ACTIVE REGISTRATION AGREEMENT AND LIABILITY WAIVER (the "Agreement and Waiver")

1. Authority to Register and/or to Act as Agent.
 You represent and warrant to Results Educational Fund ("REF") that you have full legal authority to complete this event registration on behalf of yourself **and/or any party you are registering** (the "Registered Parties"), including full authority to make use of the credit or debit card to which registration fees will be charged. As used in this Agreement and Waiver, REF refers to Results Educational Fund and any and all subsidiaries or affiliated entities including RESULTS Inc. and their officers, employees, contractors, subcontractors and agents.

If you are registering a child under the age of 18 or an incapacitated adult you represent and warrant that you are the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, you agree that the terms of this Agreement and Waiver shall apply equally to all Registered Parties. By registering a child under 13, you agree and consent to the collection of that child's information which you provide for the purposes of registration.

2. Assumption of Risk.
 YOU UNDERSTAND that participation in the event is potentially hazardous, and that a registered party should not participate unless they are medically able and properly trained. You understand that you will be selecting your own course, which may include public roads and facilities open to the public and upon which hazards are to be expected. You acknowledge that REF cannot control the conditions of the course you select or reduce any risks you may be exposed to. You understand that participation carries with it certain INHERENT RISKS that cannot be eliminated completely. Risks may arise from facilities, sickness, equipment, condition of participants, vehicular traffic, and theft, and may arise from your actions or inactions, or the actions or inactions of others, including other participants, or THE NEGLIGENCE OR RECKLESS CONDUCT OF REF. Consequences may include INJURY OR PHYSICAL HARM, ranging from minor injuries to catastrophic injuries including death, AND PROPERTY DAMAGE AND LOSS. YOU FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND RESPONSIBILITY FOR ALL LIABILITY, LOSSES, COSTS, CLAIMS, OR DAMAGES incurred as a result of your participating in the Event.


3. Waiver.
 YOU UNDERSTAND AND AGREE THAT IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN THE EVENT, YOU AND ANY REGISTERED PARTY, THE HEIRS, PERSONAL REPRESENTATIVES OR ASSIGNS OF YOU OR THE REGISTERED PARTY DO HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE REF FOR ANY AND ALL LIABILITY FROM ANY AND ALL CLAIMS ARISING FROM PARTICIPATION IN THE EVENT BY YOU OR ANY REGISTERED PARTY.

You further agree that if, despite this release, you or anyone on your behalf makes a claim against REF, you will indemnify and save and hold harmless REF from any litigation expenses, attorney fees, loss, liability, damage, or cost any may incur as a result of any such claim.

4. Applicable Law; Consent to Jurisdiction.
 By completing this event registration, both you and REF agree that the statutes and laws of Washington, DC, without regard to the conflict of laws principles thereof, will apply to all matters relating to this event registration and this Agreement and Waiver. You agree that exclusive jurisdiction for any dispute with REF resides in the courts of the District of Columbia and you further agree and expressly consent to the exercise of personal jurisdiction in the courts of the District of Columbia in connection with any such dispute.

5. Severability.
 You further expressly agree that this Agreement and Waiver is intended to be as broad and inclusive as permitted by law and that if any provision of this Agreement and Waiver shall be found to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and Waiver and shall not affect the validity and enforceability of any remaining provisions.

BY INDICATING YOUR ACCEPTANCE OF THIS AGREEMENT AND WAIVER, YOU ARE AFFIRMING THAT YOU HAVE READ AND UNDERSTAND THIS AGREEMENT AND WAIVER AND FULLY UNDERSTAND ITS TERMS. YOU UNDERSTAND THAT YOU ARE GIVING UP SUBSTANTIAL RIGHTS, INCLUDING THE RIGHT TO SUE. YOU ACKNOWLEDGE THAT YOU ARE SIGNING THE AGREEMENT AND WAIVER FREELY AND VOLUNTARILY, AND INTEND BY YOUR ACCEPTANCE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
